Dressage Percentage Class	Ride any Dressage or Event test(s) up through 1 st Level 1 or Preliminary. Specify test on entry. Test must take place in a small ring. High score wins. Class may be divided upper/lower level.		

For your information:

- Entry fees: \$130/ Mini-Trial division, \$65/ Combined Test division, \$100/ two consecutive Combined Test divisions if same horse and rider, \$20/ Dressage Percentage class test ridden.
- Stabling: On grounds (limited) at \$45/night (includes \$15 refundable muck-out fee). **(Straw bedding ONLY. No shavings please. Shavings = \$30 cleanout fee)** Tack stall & non-compete horses same price (priority given to competing horses).
- Hay and straw will **not** be sold so bring your own.
- Negative coggins dated within 12 months must accompany each entry. (Must also have current health certificate on hand.)
- Refunds: Before closing date: less \$20 office fee. After closing date: none. Bad weather cancellation - none. Withdrawals must be made in writing and received or emailed by 9:00 PM, closing date.
- Late entries received after the closing date must include an additional \$25 late fee. No guarantee of acceptance. Incomplete entries/ coggins/ missing fees are considered late as of closing. Fee for **ANY** changes after the closing date - \$20.
- Medical personnel, concessions, and photographer on grounds. Vet and farrier on call.
- Dressage arenas will be outdoor sand rings.
- Dressage Test readers will be permitted in the Green Starter and Starter divisions and the Dressage percentage class.
- Medical armbands required for all jumping; coats and braiding not required.
- Awards: 1st – 10th place ribbons. 1st place trophy for each mini-trial and combined test division.
- Ride times will be posted on the web on July 25th. No postcards will be sent. <http://summerschool.home.insightbb.com>
